AAA4 Staff are now finalizing contract packets for State Fiscal Year (SFY) 2020-2021. The Agency will be working to get all agreements fully executed in a timely fashion.

AAA4 does not anticipate receiving funds from the State until September 2020. Once that occurs, approved Monthly Financial Requests (MFRs) for July 2020 will be paid as soon as possible. All Funded Partners should plan appropriately.

No Funded Partner is obligated to expend AAA4 funds prior to receiving confirmation from the Agency that reimbursement is forthcoming. <u>AAA4 requires any Funded Partner electing to temporarily suspend or reduce the provision of services on or after July 1, 2020 to notify the Agency in writing.</u>

Baseline Older Americans Act awards for SFY 2020-21 are shown in the charts below. The dollar figures shown originate from the Area Plan Budget Display released by the California Department of Aging on April 30, 2020. Due to COVID-19, delays have occurred in the appropriations process at both the federal and state levels. Consequently, AAA4's initial baseline totals are significantly less than expected for the balance of Federal Fiscal Year (FFY) 2020 and less than anticipated for FFY 2021.

To remedy this situation, AAA4 has only applied these temporary shortfalls to those service categories known to be providing higher than usual levels of service (i.e., Transportation, Legal, Information & Assistance, Home-Delivered Meal and Caregiver Support). As soon as AAA4 receives its share of CARES Act dollars from CDA, we will use the first portion of said funds to fully "fill" the temporary shortfalls.
