**SUBJECT: Approve Committee Recommendations** 

The Legislative Committee met on April 5 to review bills pertaining to Older Adults. The Committee is asking the full Advisory Council to consider voting in support of each of the bills listed below and to be prepared to take action during the 4/18 Council meeting. The text of each bill is attached for your review. Letters of support are pending.

- AB 506 (Kalra) Long-term health facilities
- AB 1382 (Aguilar-Curry) Master Plan on Aging
- SB 222 (Hill) Discrimination: veteran or military status
- SB 280 (Jackson) Older adults and persons with disabilities: fall prevention [reconsideration]
- SB 338 (Hueso) Elder and dependent abuse: law enforcement policies [reconsideration]
- SB 453 (Hurtado) Older adults
- SB 611 (Caballero) Housing: elderly and individuals with disabilities

As noted, SB 280 and SB 338 were presented at the March Council meeting, support for the former was apparently denied and consideration of the latter was tabled. Now that legislative analyses are available on these bills, the Legislative Committee is asking the Council to reconsider them.

A vote of support by the Advisory Council authorizes the Council Chair to sign a letter which will be sent to the author(s) of the bill/request, to the appropriate Committee members and to local elected officials. It also authorizes representatives of the Legislative Committee to verbally express the Council's support for the bill/request during hearings at the State Capitol.

Should a bill be edited, the Legislative Committee will re-assess the bill and may adjust its recommendation to the Advisory Council. AB 388 and SB 228 have been amended since Council approval was granted; the Committee does not feel said changes warrant any adjustments at this time.

In accordance with Parliamentary Procedure, a majority vote of **eligible** members present shall be required to pass a motion (members who abstain from voting are <u>not</u> eligible, thus abstentions are deducted from the total number of voters). A roll call vote may be held upon request.





These maps are not the best, but whatever direction from which you are traveling, you will need to drive through Sacramento.

- You need to be on CA-99 S
- Capital City Freeway/I-80 becomes CA-99 S
- After traveling ~ 21 miles from Sacramento on CA-99 S, Take Exit 277 toward CA-104/Jackson.
- Then, at 0.12 mi turn Left onto W. Stockton Blvd.
- Then, at 0.09 mi enter the round-about and take the 3<sup>rd</sup> exit onto Twin Cities Road/CA-104/Country Hwy-E 13
- Enter the next round-about and take the 2<sup>nd</sup> exit onto Twin Cities Road/CA-104
- You will see the Raley's Grocery Store
- Raley's Event Center is a large meeting room inside of the grocery store. Walk towards the back by the Pharmacy. The meeting room is down the hallway by the Pharmacy.
